CITY RESOLUTION NO. 259-2017

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TOURISM - REGIONAL OFFICE 02 (DOT - RO2) FOR THE 28th PHILIPPINE TRAVEL MART AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral which is "*Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Tourism – Regional Office No. 02 (DOT – RO2) for the 28th Philippine Travel Mart*" was endorsed to the Seventh City Council;

WHEREAS, the Committees, to which the matter was referred to, met on September 4, 2017 to discuss the subject referral;

WHEREAS, the Philippine Tour Operators Association (PHILTOA) is preparing for the staging of the yearly Philippine Travel Mart in the country for the promotion of domestic and inbound tourism;

WHEREAS, the Committees took note of the date of the 28th Philippine Travel Mart held at the SMX Convention Center, Pasay City last September 1-3, 2017 which was already finished or overtaken by time;

WHEREAS, the Memorandum of Agreement is still needed because the activity will already be conducted annually, subject to the approval of the City Council;

WHEREAS, the Committees also took note of the manifestation of Hon. Atty. Mary Marjorie P. Martin Chan to inform the Local Chief Executive Office that Memoranda should be submitted beforehand to give ample for the City Council to review and approve them before they are being implemented;

WHEREAS, upon review of the Memorandum of Agreement, the Committee on Rules, Laws and Ethics and Committee on Tourism, Culture and Arts recommend for the adoption and approval of the Memorandum of Agreement and a Resolution granting authority to the City Mayor to sign for and on


behalf of the Tuguegarao City the said Memorandum of Agreement with the Department of Tourism - Regional Office No. 02.
