WHEREAS, SHAYNE SIANE C. YOUNG was chosen as participating youth representing Region 2 to the 44th Ship for Southeast Asian and Japanese Youth Program (SSEAYP);

WHEREAS, since 1974, SSEAYP has sent Philippine Youth Ambassadors of Goodwil and brought the message of love and peace in an extraordinary cruise around Southeast Asia and Japan through its comprehensive on-board and home stay programs with almost four hundred (400) Youth Ambassadors from Japan and ASEAN countries as they live together in MS Nippon Maru for fifty-two (52) days;
