CITY RESOLUTION NO. 263-2017

A RESOLUTION EARNESTLY REQUESTING SECRETARY ARTHUR P. TUGADE FOR THE UPGRADING OF THE TUGUEGARAO CITY AIRPORT INTO AN INTERNATIONAL AIRPORT AND AN ALTERNATIVE SITE WITHIN THE CITY FOR A 300-HECTARE LAND IN EITHER BARANGAYS PENGUE-RUYU, LINAO EAST, LINAO NORTE, CARIG SUR, CARIG NORTE OR DADDA TO NAMABBALAN AND TO PROVIDE FUNDS FOR THE CONDUCT OF ITS FEASIBILITY STUDIES

WHEREAS, the Seventh City Council in session assembled last August 22, 2017 referred the letter request of then former City Mayor Hon. Bienvenido C. De Guzman II for the passage of a City Resolution for the retention of the Tuguegarao City Airport to the Committee of the Whole with the Committee on Rules, Laws and Ethics as the Lead Committee;

WHEREAS, the RDC2 Infrastructure Development Committee in its Special Meeting on September 06, 2017 favorably endorsed the conduct of a Feasibility Study for an international Airport in the province in consideration of the two sites that have earlier been identified;

WHEREAS, the Tuguegarao City Government has also proposed an alternative site within the City for a 300-hectare land in either Barangays Pengue-Ruyu, Linao East, Linao Norte, Carig Sur, Carig Norte or Dadda to Nambabbalam;

WHEREAS, there is a need for a regional/international airport that is able to provide and accommodate the necessary facilities to effectively cater to and accelerate the economic prosperity of the province and the region as a whole on a long-term development perspective;

WHEREAS, the feasibility study shall consider two possible sites for the location of the international airport, namely: at the Tri-boundary of Solana-Tuao-Piat, Cagayan and either within Barangays Pengue-Ruyu, Linao East, Linao Norte, Carig Sur, Carig Norte or Dadda to Namabbalan, Tuguegarao City.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the passage of a resolution earnestly requesting Secretary Arthur P. Tugade for the upgrading of the Tuguegarao City







Airport into an International Airport and an alternative site within the City for a 300-hectare land in either barangays Pengue-Ruyu, Linao East, Linao Norte, Carig Sur, Carig Norte or Dadda to Namabbalan and to provide funds for the conduct of its feasibility studies.

RESOLVED FURTHER, that a copy of this Resolution be forwarded to Secretary Arthur P. Tugade of the Department of Transportation and Hon. Gov. Manuel N. Mamba, Chair of the Infrastructure Development Council/RDC-02, for Consideration and Approval.

On joint motion and with the abstention of Hon. Maila Rosario T. Que, CITY RESOLUTION NO. 263-2017 was APPROVED in plenary under suspended rules.
