CITY RESOLUTION NO. 271-2017

**RESOLUTION GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE,
HON. ATTY. JEFFERSON P. SORIANO, TO ENTER INTO A MEMORANDUM OF
AGREEMENT BETWEEN TUGUEGARAO CITY GOVERNMENT
AND VISTA GREEN CORPORATION**

WHEREAS, the request for amendment of City Resolution No. 185-2017 for an authority to sign the Memorandum of Agreement with the Vista Green Corporation was endorsed to the Seventh City Council by the former City Mayor, Hon. Bienvenido C. De Guzman II on August 22, 2017;

WHEREAS, the Committee initially met on March 16, 2017 with resource persons to discuss the subject referral titled *“Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Vista Green Corporation (VC) for the installation, operation and maintenance of the small, modular, renewable energy of Municipal Solid Waste (MSW) Processing Project, for consideration;”*

WHEREAS, the representative of Vista Green Corporation (VC) gave a brief presentation about the company’s profile and offered Waste Processing Services to the City Government through the installation, procurement, operation and maintenance of the proposed Waste Processing Plant (WPP);

WHEREAS, the Committee again met on April 28, 2017 to finally deliberate on the Memorandum of Agreement with the presence of resource persons;

WHEREAS, the project is pursuant to R.A. No. 9003, otherwise known as the “Ecological Solid Waste Management Act of 2000;”

WHEREAS, the technological services offered will address the issue on Ecological Waste Management and Solid Waste Disposal of the Tuguegarao City Government to eliminate the need for additional dumpsite/landfill;

WHEREAS, Vista Green Corporation (VC) will invest the Waste Processing Plant at No Cost to the Local Government Unit of Tuguegarao City under the terms and conditions in the Memorandum of Agreement for a period of fifteen (15) years renewable for ten (10) years and two (2) year decommissioning period;

WHEREAS, the Tuguegarao City Government shall provide only a site to house the two (2) units of Waste Processing Plant and deliver its existing and daily segregated Solid Waste Materials for the Processing of Vista Green Corporation who shall process the same and shall own it;

WHEREAS, upon review of the said request, the Committee favorably recommends for the approval of the Memorandum of Agreement and the passage of a Resolution Granting Authority to the Local Chief Executive, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Vista Green Corporation (VC);

WHEREAS, the venue of any legal actions arising out of the Memorandum of Agreement shall be Quezon City;


WHEREAS, the comments, observations and questions of Hon. Maila Rosario T. Que are appended to this resolution.
