RESOLUTION APPROVING THE RELOCATION OF THE UNINSTALLED FIFTY-NINE (59) LAMP POSTS FROM PART OF NAMABBALAN NORTE-NAMABBALAN SUR TO PORTION OF CARIG SUR-PORION OF CARIG NORTE, TUGUEGARAO CITY

WHEREAS, one of the top projects of the present administration is the Installation of Streetlights for Tuguegarao City;

WHEREAS, one of the approved programs under the 20% Development Fund for CY 2017 is the Installation of Streetlights at part of Dadda-Namabbalan Sur and part of Gosi-Libag Road, Tuguegarao City;

WHEREAS, there is an ongoing Installation of Roadway Luminaire along N1/Cagayan Valley Road specifically along Namabbalan which was confirmed by the 3rd Engineering District Office through Engr. Danilo U. Tabilas;

WHEREAS, the ongoing Installation of the Roadway resulted to the uninstillation of fifty-nine (59) lamp posts of the City due to overlapping of project site;

WHEREAS, the share from the Road Users Tax was already utilized for the installation of streetlights for Carig Norte and Carig Sur and the part not covered will be continued by the city government;

WHEREAS, the Local Chief Executive requested the Seventh City Council for the passage of a resolution approving the relocation of the aforementioned lamp posts;

WHEREAS, pursuant to Committee Report No. 165-2017 of the Committee on Infrastructure and Public Utilities, the Seventh City Council deemed it proper, necessary and beneficial to approve the relocation of the uninstalled fifty-nine (59) lamp posts during the 55th Regular Session.




