**CITY RESOLUTION NO. 276-2017**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE COMMUNITY BASED MONITORING SYSTEM (CBMS) NETWORK TEAM AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) ON THE INSTITUTIONALIZATION OF THE COMMUNITY BASED MONITORING SYSTEM AS A PLANNING AND MONITORING TOOL AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, the referral which is “*Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to enter for and on behalf of the Tuguegarao City government the Memorandum of Agreement with the Community Based Monitoring System (CBMS) Network Team and the Department of the Interior and Local Government (DILG) on the institutionalization of the community based monitoring system as a planning and monitoring tool at the City*” was endorsed to the Seventh City Council;

**WHEREAS**, the Committee, to which the matter was referred to, met on September 8, 2017 to discuss the subject referral;

**WHEREAS**, the Community Based Monitoring System (CBMS) was developed as a tool for evidence based policy making and program implementation;

**WHEREAS**, the CBMS Network Team provides technical assistance to LGUs on the development and institutionalization of CBMS and its use for planning, program formulation and impact monitoring;

**WHEREAS**, it is a collaboration among the CBMS Network Team, the Department of the Interior and Local Government (DILG) through the Bureau of Local Government Development and the Tuguegarao City Government through its City Planning and Development Office;


