CITY RESOLUTION NO. 278-2017

RESOLUTION APPROVING THE REPROGRAMMED PROGRAM OF WORK AND CHANGING THE CLASS EXPENSE FROM MAINTENANCE AND OTHER OPERATING EXPENSE (MOOE) TO CAPITAL OUTLAY OF THE REPAIR AND MAINTENANCE OF ROADS AT LECAROS-CATAGGAMAN-BUNTUN ROAD AND LINAO-CARIG ROAD UNDER THE CONTINUING 20% DEVELOPMENT FUND OF CY 2016 ANNUAL BUDGET OF TUGUEGARAO CITY

WHEREAS, pursuant to Section 4 of Appropriation Ordinance No. 04-2015 – “*An Ordinance Authorizing the Annual Budget of Tuguegarao City, Cagayan for Calendar Year 2016*”, the disbursement of funds shall be made in accordance with the Programs of Work and any realignment of funds shall be approved by the council;

WHEREAS, pursuant to the Local Government Code of 1991, any change in the Annual Budget shall be authorized by the Sangguniang Panlungsod;

WHEREAS, the approved Program of Work of the project “Repair and Maintenance of Roads” at Lecaros-Cataggaman-Buntun Road and Linao-Carig Road was classified as Maintenance and Other Operating Expenses (MOOE) allocated under the Continuing 20% Development Fund of CY 2016 Annual Budget of Tuguegarao City amounting to Three Million Five Hundred Thousand Pesos (P3,500,000.00);

WHEREAS, the program was originally intended for simple repairs, but due to the actual field condition, major repairs are needed and removal and replacement of existing pavement is recommended;

WHEREAS, the change in the scope of work of the said project is considered as Capital Outlay, hence, there is a need for the reprogramming of the Program of Work and changing the Class Expense from Maintenance and Other Operating Expense (MOOE) to Capital Outlay under the same fund.


