RESOLUTION APPROVING THE REPROGRAMMING OF THE UNEXPENDED BALANCE FOR PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR USE OF THE VICE MAYOR'S OFFICE

WHEREAS, the City Government had an Unexpended Balance of One Million Eight Hundred Forty Four Thousand Three Hundred Eighty Pesos (Php1,844,380.00) from the procurement of two units Mini-Buses under Public Bidding-Goods-2017-2018.

WHEREAS, the amount of Eight Million Pesos (Php8,000,000.00) was allocated for said procurement under City Resolution No. 207-2017, and the bid price of the Lowest Calculated and Responsive Bidder (Genesis Auto Corp.) was Six Million One Hundred Fifty Five Thousand Six Hundred Twenty Pesos (Php6, 155, 620.00) thereby reflecting the aforementioned Unexpended Balance.

WHEREAS, the office of the Vice Mayor service vehicle is an ageing 10 year old model 2007 Innova (SGH-256) which is prone to mechanical and electrical malfunctions.

WHEREAS, the Vice Mayor's Office needs a new service vehicle for transportation requirements of its employees in furtherance of their duties, functions and responsibilities.

WHEREAS, the City Budget Officer has certified that the aforementioned amount remained unexpended from the purchase of the two (2) units mini buses charged against continuing appropriation under General Fund.



RESOLVE, AS IT IS HEREBY RESOLVED, to approve the Reprogramming of the Unexpended Balance for procurement of one (1) unit passenger van for use of the Vice Mayor's Office.
