**WHEREAS**, his exemplary performance has affirmed that Tuguegarao City is indeed the Center Of Excellence;




On motion of Hon. Arnel T. Arugay and without any objection, **CITY RESOLUTION NO. 293-2017** was **APPROVED** under suspended rules.
