**CITY RESOLUTION NO. 297-2017**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT  
 WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES-  
 ENVIRONMENT MANAGEMENT BUREAU (DENR- EMB) FOR THE IMPLEMENTATION  
 OF THE ADOPT-AN-ESTERO/WATERBODY PROGRAM  
 AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF  
 THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, the Referral which is “Indorsement of the City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Environment and Natural Resources- Environment Management Bureau (DENR- EMB) for the implementation of the Adopt-an-Estero/Waterbody Program” was endorsed to the Seventh City Council;

**WHEREAS**, the Committee, to which the matter was referred to, met on October 11, 2017 to discuss the subject referral;

**WHEREAS**, the Adopt-on-Estero/Waterbody Program is a continuous project undertaken by the DENR-EMB RO2 in collaboration and partnership with the LGU-Tuguegarao City, the different barangays in Tuguegarao City, line agencies and stakeholders;

**WHEREAS**, the Old Memorandum of Agreement entered into by the concerned parties expired last July 17, 2017, hence, the need for its renewal;

**WHEREAS**, upon review of the Memorandum of Agreement, the Committee on Climate Change, Environmental Protection and Ecology recommends for the adoption and approval of the Memorandum of Agreement and a Resolution granting the City Mayor an authority to sign for and on behalf of the Tuguegarao City the said Memorandum of Agreement with the Department of Environment

and Natural Resources- Environment Management Bureau (DENR- EMB) RO2 and the different selected barangays, to wit:


