**RESOLUTION AUTHORIZING THE CITY MAYOR,
 HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF THE
 TUGUEGARAO CITY GOVERNMENT THE CONTRACT OF LEASE WITH THE PHILIPPINE
 HEALTH INSURANCE CORPORATION FOR THE LEASE OF AN ADDITIONAL OFFICE
 SPACE ADJACENT TO THEIR LOCAL HEALTH INSURANCE OFFICE AT THE THIRD
 FLOOR OF THE TUGUEGARAO CITY CENTRAL PUBLIC MARKET**

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth), a government owned and controlled corporation, duly registered, organized and existing by virtue of RA 7875 as amended by RA 9241 further amended by RA 10606, has formally signified its intent to lease an additional office space adjacent to their Local Health Insurance Office at the 3rd floor of the Tuguegarao Central Public Market;

WHEREAS, the Tuguegarao City Government is the registered owner of the market stalls of the said Central Public Market located at Tuguegarao City, Cagayan;

WHEREAS, the Committee on Ways and Means and Committee on Market, after having studied the provisions stipulated in the Contract of Lease, found the terms and conditions beneficial to both parties, subject to payment of necessary fees and charges pursuant to the Market Code of Tuguegarao City;

WHEREAS, the Seventh City Council during their 59th Regular Session approved the request of the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and in behalf of the Tuguegarao City Government the contract of lease with Philhealth;




On motion of Hon. Jude T. Bayona and without any objection, **CITY RESOLUTION NO. 299-2017** was **APPROVED** under suspended rules.
