# **CITY RESOLUTION NO. 300-2017**

RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,
HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE
TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT
WITH THE DEPARTMENT OF HEALTH, REGIONAL OFFICE NO. 2 (DOH-RO2)
ON THE MUNICIPAL DATA COLLECTION FOR REPORTING TO THE
HEALTH SECTOR PERFORMANCE MONITORING UNIT

WHEREAS, the Department of Health by virtue of its mandate holds the over-all technical authority in health with three major roles of leadership: regulator in health; enabler and capacity builder; and administrator of special health services;

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all Local Government Units or LGUs at all levels;

WHEREAS, DOH Department Order No. 2016-0170 regarding the "Establishment of a Health Sector Performance Monitoring Unit" specifies the need for an effective monitoring and evaluation system, wherein the unit will be responsible for monitoring health sector performance as it enables translation of national priorities for health reforms into organizational and individual objectives and provides focus on results and enhances accountability at different levels of operation;

WHEREAS, the Philippine Health Agenda for 2016-2020 under its strategy "ACHIEVE" for financial protection, better health outcomes and responsive health systems stipulates strategy "I" – Invest in eHealth and data for decision making, thus, the health sector shall continue to ensure appropriate collection, consolidation, validation and analysis of data for the Health Sector Performance Monitoring Unit (HSPMU) to provide a more meaningful and comprehensive picture of achievements in the health sector in general and in particular to provide timely & quality information on health sector performance as a guide in improving program management, policy formulation, planning and resource allocation & decision making;



WHEREAS, the Data Collection Tool developed by DOH through the National Health Sector Performance Monitoring Unit (NHSPMU) lodged under the Office for Policy and Health Systems Cluster is implemented as the official reporting tool, which requires data that shall come from various institutions as its point of source such as Rural Health Units/City Health Offices, LGU-owned hospitals, DOH-Retained Hospitals, and Local Civil Registries and Vital Statistics Offices;

WHEREAS, the LGU agrees that it shall comply with all applicable Philippine laws, policies, ordinances, memoranda and other issuances or mandates related to data acquired from their Local Civil Registry and Vital Statistics Office to utilize on generating reports for submission to the National Health Sector Performance Monitoring Unit, further, the LGU agrees to hold harmless and indemnify the DOH RO II against any loss or damage, to include reasonable attorney's fees that may be sustained by DOH RO II by reason of the failure of the LGU to comply with such laws, policies, ordinances, memoranda and other issuances or mandates and vice versa;

WHEREAS, all data/information lodged in the jurisdiction of the LGU under its supervision, care and/or custody are rightly owned by the LGU, even after this MOA has been terminated or has expired;

WHEREAS, both parties hereby unconditionally and irrevocably agree to preserve and maintain with utmost confidence all Confidential Information, use the said information in the performance of services in accordance to this agreement and segregate the Confidential Information accordingly respective of its rightful owners; all confidential health information or medical records information that are exchanged among the parties shall remain the property of the LGU. Other policies on Confidential Health Information shall conform to Republic Act No. 10173 or the "Data Privacy Act of 2012" and its implementing rules and regulations;

WHEREAS, after an extensive discussion during the committee meeting held for the said purpose, the Committee on Health and Sanitation found the terms and condition in the Memorandum of Agreement to be in order and with merit;

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant authority to the City Mayor, Hon. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Department of Health, Regional Office No. 2 (DOH-RO2) on the Municipal Data Collection for Reporting to the Health Sector Performance Monitoring Unit.

On joint motion of Hon. Jude T. Bayona and without any objection, City Resolution No. 300-2017 was APPROVED under suspended rules.
