CITY RESOLUTION NO. 305-2017

A RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, AN AUTHORITY TO SIGN FOR AND BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH TUGUEGARAO CITY SCIENCE HIGH SCHOOL FOR THE IMPLEMENTATION OF THE PROJECT TITLED "WORK IMMERSION PARTNERSHIP PROGRAM"

WHEREAS, the referral which is "Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and behalf of the Tuguegarao City Government the Memorandum of Agreement with Tuguegarao City Science High School regarding the Work Immersion Partnership Program" was endorsed to the Seventh City Council;

WHEREAS, the Committee, to which the matter was referred to, met on October 10, 2017 and October 26, 2017 to discuss the subject referral;

WHEREAS, the Senior High School of Tuguegarao City Science High School is a stand-alone unit which solely offers the academic track particularly the Science, Technology, Engineering and Mathematics (STEM) strand. Cognizant of the existence of the K to 12 Basic Education Program in which one of the goals is to develop learners the competencies, work ethics and values relevant to pursuing further education and/or joining the world of work, WORK IMMERSION is a required subject. This subject will offer opportunities for senior high school students to become familiar with the workplace, for employment simulation and to apply the competencies in areas of specialization or applied subjects in realistic work atmospheres;

WHEREAS, the Tuguegarao City Government will accommodate the Tuguegarao City Science High School students in the City Engineering Office, City Health Office and Peoples General Hospital this semester, SY 2017-2018. They need to complete 80 hours of training wherein they shall be oriented about the nature of the said offices, perform work-related activities and participate in the programs related to their chosen field of specialization;



WHEREAS, upon review of the Memorandum of Agreement, the Committee on Education recommended for the adoption and approval of the Memorandum of Agreement and a Resolution Granting the City Mayor, Hon. Atty. Jefferson P. Soriano, an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Tuguegarao City Science High School.

NOW, THEREFORE RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement with the Tuguegarao City Science High School regarding the Work Immersion Partnership Program.

RESOLVED FURTHER, to grant authority to the City Mayor to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement.
