CITY RESOLUTION NO. 307-2017

A RESOLUTION APPROVING THE MEMORANDUM OF UNDERTAKING WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, RO2 REPRESENTED BY ENGR. CESAR. S. SIADOR, JR. FOR THE IMPLEMENTATION OF THE ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM AND CENTRAL PUBLIC MARKET AND DON DOMINGO PUBLIC MARKET IN TUGUEGARAO CITY AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF UNDERTAKING

WHEREAS, Section 10 of Republic Act No. 9003, known as the Ecological Solid Waste Management Act of 2000, states that pursuant to the relevant provisions of the Local Government Code of 1991 (RA 7160), local government units are primarily responsible for the implementation Land enforcement of the provisions of RA 9003;

WHEREAS, the Ecological Solid Waste Management Act 2000 (RA 9003) provides for an Ecological Solid Waste Management System, creating the necessary institutional mechanism and incentives, and appropriating funds therefore to guide local government units (LGUs) in the achievement of the objectives of the Act;

WHEREAS, Section 8 of Republic Act No. 9003 mandates the DENR to provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, the Environmental Management Bureau (EMB) is willing and amenable to give assistance to the local government unit of Tuguegarao City for the implementation of the Ecological Solid Waste Management Program;

WHEREAS, the Referrals which are "Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign the Memorandum of Undertaking to be entered into between the Tuguegarao City Govenrment and the Department of the Environment

and Natural Resources-Environmental Management Bureau (DENR-EMB) RO2" and "Indorsement of the City Mayor, Hon. Atty.Jefferson P. Soriano, requesting for the passage of a City Resolution authorizing the City Mayor to enter into a Memorandum of Agreement with the DENR-EMB for the implementation of Ecological Solid Waste Management Program" were endorsed to the Seventh City Council;

WHEREAS, the Committee, to which the matters were referred to, met on October 26, 2017 to discuss the subject referrals;

WHEREAS, upon review of the Memorandum of Undertaking, the Committee on Climate Change, Environmental Protection and Ecology recommended for the adoption and approval of the Memorandum of Undertaking and a Resolution granting the City Mayor an authority to sign for and on behalf of the Tuguegarao City the said Memorandum of Undertaking with the Department of Environment and Natural Resources (DENR) RO2.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to grant the request for the approval of the Memorandum of Undertaking and the passage of a corresponding Resolution granting authority to the City Mayor, Hon.Atty. Jefferson P. Soriano, to sign for and on behalf of the City Government the Memorandum of Agreement with the Department of Environment and Natural Resources (DENR RO2) represented by Engr. Cesar. S. Siador, Jr. for the implementation of the Ecological Solid Waste Management Program and Central Public Market and Don Domingo Public Market in Tuguegarao City.

On motion of Hon. Raymund P. Guzman and without any objection, with the exclusion and non-participation of Hon. Maila Rosario T. Que who asked permission to leave early due to health reasons, **City Resolution No. 307-2017** was **APPROVED** under suspended rules.
