
Madam:

CITY RESOLUTION NO. 315-2017

RESOLUTION ADOPTING AND APPROVING THE LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) OF TUGUEGARAO CITY CYs 2017-2019

WHEREAS, Section 114 (a) of Republic Act No. 7160 or the Local Government Code of 1991 provides that “the policies, programs and projects proposed by the local development council shall be submitted to the sanggunian for appropriate action”;

WHEREAS, Section 305 (i) of Republic Act No. 7160 or the Local Government Code of 1991 provides that “local budgets shall operationalize approved local development plans”;

WHEREAS, the Local Development Investment Plan (LDIP) is a basic programming document of prioritized programs, projects and activities (PPAs) to be implemented annually within a period of three (3) years for cities and is linked to the budget;

WHEREAS, DILG-NEDA-DBM-DOF Joint Memorandum Circular 2016-01 reiterated the harmonization of national and local plans and highlighted the role of the city in ensuring that plans at all levels are complementary;




On motion of Hon. Danilo L. Baccay and without any objection, **CITY RESOLUTION NO. 315-2017** was **APPROVED** under suspended rules.
