**CITY RESOLUTION NO. 322-2017**

**A RESOLUTION APPROVING THE CONTRACT OF SERVICE BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, DEPARTMENT OF LABOR AND EMPLOYMENT RO2 AND MR. STAR VIC A. POMAR AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID CONTRACT OF SERVICE**

**WHEREAS**, the referral which is “Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign the contract of service to be entered into between and among the Tuguegarao City Government, Department of Labor and Employment RO2 and Mr. Star Vic A. Pomar” was endorsed to the Seventh City Council;

**WHEREAS**, the Committee, to which the matter was referred to, met on November 11, 2017 to discuss the subject referral;

**WHEREAS**, the Department of Labor and Employment, Regional Office No. 02 is implementing Special Programs for Employment of Students (SPES) and Government Internship Program (GIP);

**WHEREAS**, Mr. Star Vic Graynior A. Pomar is a co-partner of DOLE in the implementation of the various programs of the department, hence, the need for the contract of service;

**WHEREAS**, upon review of the Contract of Service, the Committee on Rules, Laws and Ethics recommends for the adoption and approval of the Contract of Service and a Resolution granting the City Mayor an authority to sign for and on behalf of the City Government the said Contract of Service to be entered into with the Department of Labor and Employment RO2 and Mr. Star Vic Graynior A. Pomar.





On motion of Hon. Raymund P. Guzman and without any objection, **CITY RESOLUTION NO. 322-2017** was **APPROVED** under suspended rules.
