## A RESOLUTION APPROVING THE DEED OF DONATION WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY AND GRANTING THE CITY MAYOR AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID DEED OF DONATION

WHEREAS, the referral which is "Indorsement of the City Mayor, Hon. Atty Jefferson P. Soriano, requesting for an authority to sign the Deed of Donation between the Tuguegarao City Government and the Department of Information and Communications Technology" was endorsed to the Seventh City Council;

WHEREAS, the committees, to which the matter was referred to, met on November 11, 2017 to discuss the subject referral;

WHEREAS, the Integrated Government Philippines (iGovPhil) Project was a joint project of the Department of Science and Technology - Advanced Science and Technology Institute (DOST-ASTI) and the then Information and Communications Technology Office (ICTO) now Department of Information and Communications Technology (DICT);

WHEREAS, iGovPhil aims to provide a government-shared network facilities which will be of great help to the City Government in the Implementation of the iGovPhil Project;

WHEREAS, the DICT is willing to donate one (1) allied Telesis GS 2002/SP-60 Media Converter, one (1) allied Telesis SPLX10 SFP Module and one (1) Optical Distribution Frame to LGU Tuguegarao City;
