CITY RESOLUTION NO. 326-2017

**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,
 HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE
 TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA)
 WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) RO2
 FOR THE NATIONAL HOUSEHOLD TARGETING
 SYSTEM FOR POVERTY REDUCTION**

WHEREAS, the Philippine Constitution declares that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services and promote full employment, a rising standard of living and an improved life for all;

WHEREAS, in line with the above declaration, the Department of Social Welfare and Development (DSWD) is mandated to implement the National Household Targeting System for Poverty Reduction (NHTS-PR) also known as Listahan;

WHEREAS, the project aims to establish a system for identifying who and where the poor households are, which shall serve as a basis in the selection of beneficiaries of social protection programs nationwide;

WHEREAS, access and data sharing shall be in accordance with Republic Act No. 10173 or the Data Privacy Act of 2012 and its Implementing Rules and Regulations;

WHEREAS, in order to ensure the successful implementation of the project, there is a need for the Tuguegarao City Government to enter into a Memorandum of Agreement (MOA) with the DSWD RO2;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement (MOA);

WHEREAS, after a perusal and review of the general provisions as well as the roles and obligations of the parties involved in the MOA in a committee meeting held for the said purpose, the Committee on Social Services found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City;

WHEREAS, after the presentation and adoption of Committee Report No. 217-2017, the Seventh City Council during its 63rd Regular Session deemed it proper and necessary to grant the herein request.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED** to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) RO2 for the National Household Targeting System for Poverty Reduction.

RESOLVED further, to furnish a copy of this resolution to the Department of Social Welfare and Development (DSWD) RO2 for information and proper action.
