**RESOLUTION AMENDING CITY RESOLUTION NO. 274-2017 TITLED
 “RESOLUTION ENDORSING THE LIST OF PRIORITY PROGRAMS/PROJECTS AND
 AFFIRMING THAT THE CONSTRUCTION OF MASONRY DRAINAGE STRUCTURE
 IS PART OF THE DULY APPROVED ANNUAL INVESTMENT PLAN (AIP)
 AND LOCAL DEVELOPMENT PLAN PROGRAM (LDIP)”**

WHEREAS, the project proposal of the construction of the Masonry Drainage Structure in Tanza, Tuguegarao City is an identified project for the utilization of the Fiscal Year 2017 Government Support Fund-Financial Assistance to Local Government Units (LGSF-FA to LGUs) as stated in the request of the Local Chief Executive;

WHEREAS, the Masonry Drainage is one of the priority programs/projects in the duly approved Annual Investment Plan (AIP) and Local Development Investment Program (LDIP) of the Tuguegarao City Government;

WHEREAS, the passage of a resolution is a requirement for the release of the One Million Pesos (P1,000,000.00) Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FA to LGUs);

WHEREAS, the Committee on Infrastructure and Public Utilities in a meeting acting on the indorsement of the Local Chief Executive requesting for a resolution for the herein-stated Construction of Masonry Drainage Structure favorably recommended for the passage of the said resolution;


