**CITY RESOLUTION NO. 332-2017**

**A RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDA OF AGREEMENT WITH LINAO NATIONAL HIGH SCHOOL FOR THE IMPLEMENTATION OF THE PROJECT TITLED “WORK IMMERSION PARTNERSHIP PROGRAM”**

**WHEREAS**, the referral which is “*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of the Tuguegarao City Government the Memoranda of Agreement with Linao National High School regarding the Work Immersion Partnership Program*” was endorsed to the Seventh City Council;

**WHEREAS**, the Committee on Education to which the matter was referred on November 21, 2017 met on November 27, 2017 to discuss the subject referral;

**WHEREAS**, the Senior High School of Linao National High School under the Academic Track is offering Science, Technology, Engineering and Mathematics (STEM) strand and Technology, Vocational, Livelihood (TVL) track. Cognizant of the existence of K to 12 Basic Education Program in which one of the goals is to develop learners the competencies, work ethics and values relevant to pursuing further education and/or joining the world of work, WORK IMMERSION is a required subject. This subject will offer opportunities for senior high school students to become familiar with the work place, for employment stimulation and to apply the competencies in areas of specialization or applied subjects in realistic work atmospheres;

**WHEREAS**, the Tuguegarao City Government will accommodate the twenty-one (21) Senior High School students for SY 2017-2018. Ten (10) students under the TVL-Carpentry NC II strand for at least 240 hours training; and five (5) students under the TVL-Information Communication Technology strand for at least 240 hours training. They need to complete the training wherein they shall be oriented

about the nature of offices, perform work-related activities and participate in programs which are related to their chosen field of specialization;

**WHEREAS**, upon review of the Memoranda of Agreement, the Committee on Education recommended for the adoption and approval of the Memoranda of Agreement and a Resolution Granting the City Mayor, Hon. Atty. Jefferson P. Soriano, an authority to sign for and on behalf of the Tuguegarao City Government the Memoranda of Agreement with Linao National High School for the Work Immersion Partnership Program.


