CITY RESOLUTION NO. 338-2017

RESOLUTION GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE NO. 02 (DOLE-RO2) FOR DOLE KABUHAYAN PROGRAM PARTICULARLY FOR THE SAPATEROS OF TUGUEGARAO CITY

WHEREAS, the current Administration has directed all Cabinet members to immediately implement poverty reduction projects in all regions;

WHEREAS, in line with the above declaration, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE endeavors to contribute to reducing poverty and vulnerability to risk of the poor, vulnerable, and marginalized workers by providing them access to livelihood undertakings under the DOLE Livelihood (Kabuhayan) Program, pursuant to the provisions of DO No. 137, series of 2014;

WHEREAS, the project of DOLE titled “Starter Kit for Sapateros” in partnership with the LGU-Tuguegarao City as the Accredited-Co-Partner (ACP) is intended to enhance and preserve the shoe repair industry in the City and to likewise increase the income of every sapatero in the City;

WHEREAS, in order to ensure the successful implementation of the project, there is a need for the Tuguegarao City Government to enter into a Memorandum of Agreement (MOA) with the Department of Labor and Employment – Regional Office No. 02 (DOLE-RO2);



WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to grant him an authority to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement (MOA);

WHEREAS, the DOLE-RO2 submitted a revised MOA which states that the project will be implemented by administration under the DOLE Livelihood (Kabuhayan) Program;

WHEREAS, after a perusal and review of the general provisions as well as the responsibilities of the parties involved in the MOA in a committee meeting held for the said purpose, the Committee on Trade, Commerce and Industry found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City;

WHEREAS, after the presentation and adoption of Committee Report No. 228-2017 and discussion on the matter, the Seventh City Council during its Regular Session deemed it proper and necessary to grant the herein request.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement (MOA) with the Department of Labor and Employment – Regional Office No. 02 (DOLE-RO2) for the DOLE Livelihood (Kabuhayan) Program titled “Starter Kit for Sapateros.”

RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Labor and Employment – Regional Office No. 02 (DOLE-RO2), for information and proper action.
