**RESOLUTION EARNESTLY REQUESTING SECRETARY ARTHUR P. TUGADE
 OF THE DEPARTMENT OF TRANSPORTATION (DOTr) FOR THE UPGRADING
 OF THE TUGUEGARAO CITY AIRPORT**

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed the request for the upgrading of the Tuguegarao City Airport to the Seventh City Council due to numerous cancellation of flights to and fro of the city, much to the inconvenience and dismay not only of the regular passengers but also of possible investors of the city;

WHEREAS, there is an urgent need to upgrade the Tuguegarao City Airport considering that it caters not only the residents of Cagayan Valley but also the residents of Kalinga and Apayao and other places;

WHEREAS, Tuguegarao City shall be the venue of an international seminar by St. Paul University Philippines, the National Convention of the Local Civil Registrars and the Cagayan Valley Regional Athletic Association (CAVRAA) 2018;

WHEREAS, after a deliberation in a meeting by the committee to which the request was endorsed, the Committee of the Whole found the request to be in order, with merit and beneficial not only to the constituents of Tuguegarao City but also to other nearby towns;

WHEREAS, during the committee meeting, the Civil Aviation Authority of the Philippines – Regional Office No. 02 (CAAP-RO2) Manager emphasized and enumerated among others the needs of the Tuguegarao City Airport relative to:

1. Construction of Passenger Terminal Building (Phase 1)



For Turn Over and Commissioning

1. Airfield Lighting System
2. Runway Widening

Proposed and undergoing Detailed Engineering

1. Construction of Passenger Terminal Building, Phase II and III
2. Construction of New Admin Building
3. Construction of New Control Tower
4. Instrument Landing System (ILS)
5. VOR/DME with Site Acquisition
6. Simple Approach Lighting System (SALS) with site acquisition

WHEREAS, pursuant to Committee Report No. 230-2017 of the Committee of the Whole, duly approved and adopted in plenary, the Seventh City Council during their 64th Regular Session deemed it proper and necessary to grant the herein request.


NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to earnestly request Secretary Arthur P. Tugade of the Department of Transportation (DOTr) for the upgrading of the Tuguegarao City Airport.

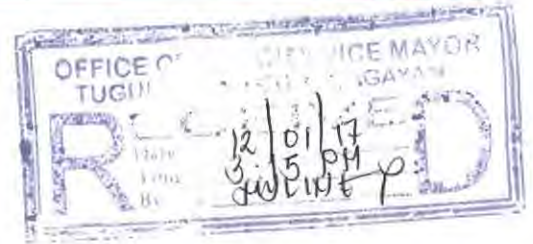
