WHEREAS, Republic Act 10121 of 2010 provides a strong legal and institutional basis for Disaster Risk Reduction and Management in the country and gives a boost to develop policies and plans, implementation of actions and measures pertaining to all aspects of disaster risk reduction and management, including good governance, risk assessment and early warning, knowledge building and awareness raising, reducing risk factors, and preparedness for effective response and early recovery;

WHEREAS, pursuant to Rule 6, Section 4, Paragraph 3 of IRR of RA 10121, the CDRRM Office shall facilitate and support risk assessment and contingency planning activities at the local level;



WHEREAS, the optimal, efficient and timely implementation of the disaster risk reduction program is essential in reducing climate-disaster risk, enhancing disaster preparedness and response capabilities at all levels.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the City Disaster Risk Reduction and Management Office Contingency Plan on Flooding.
