WHEREAS, Mr. Mateo C. Navarro, Ms. Hilaria Caronan, Ms. Cesaria Afaia and Ms. Marcelina Fadelo were awarded by the Department of Social Welfare and Development (DSWD) and the Office of the Senior Citizen Association (OSCA) of the Philippines and Federation of the Senior Citizens Association (FESCA) of Tuguegarao City the One Hundred Thousand Pesos (P100,000.00) Centenarian cash for being the rare living persons who reached the age of one hundred (100) years;

WHEREAS, the City Government of Tuguegarao hereby commends and gives due recognition to Mr. Mateo C. 
