CITY RESOLUTION NO. 349-2017

WHEREAS, the referral which is *“Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to represent the City Government in all judicial actions as a party litigant”* was endorsed to the Seventh City Council;

WHEREAS, the Committee, to which the matter was referred to, met on December 7, 2017 to discuss the subject matter;

WHEREAS, upon review of the request, the Committee recommends for the City Mayor to appear for and in behalf of the Tuguegarao City Government with full authority to enter into Pre-Trial, make admissions, denials, stipulation of facts, submit to the modes of discovery and to enter into settlement and Compromise Agreements in all cases involving the Tuguegarao City Government;

WHEREAS, the Committee on Rules, Laws and Ethics also recommends for the adoption and approval of the Resolution Granting Authority to Hon. Atty. Jefferson P. Soriano to represent the City Government in all judicial actions.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant the request for the approval of the Resolution Granting Authority to Hon. Atty. Jefferson P. Soriano to represent the City Government in all judicial actions as a party litigant.




