

APPROPRIATION ORDINANCE NO. 02-2018

**AN ORDINANCE AMENDING APPROPRIATION ORDINANCE NO. 01-2018 TITLED
 "AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01 OF
 TUGUEGARAO CITY FOR CY 2018"**

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Seventh City Council CDC Resolution No. 07, 2018 titled "*Resolution Endorsing to the 7th City Council the Approval of the Reprogramming of the Supplemental Investment Program CY 2018 for Supplemental Budget No. 01 CY 2018;*"

WHEREAS, the Seventh City Council approved the said CDC Resolution during its Special Session held on May 11, 2018;

WHEREAS, the reprogramming is justifiable as a result of the implementation of Republic Act No. 10963, also known as the Tax Reform Acceleration and Inclusion (TRAIN) Law, causing the increase of prices of construction materials, aside from the fact that the Department of Public Works and Highways through its Cagayan Third Engineering District has funded and started the procurement and construction of twelve (12) classrooms in three (3) elementary schools.

NOW, THEREFORE, be it **ORDAINED** by the Seventh City Council, to enact:

SECTION 1. TITLE. This Appropriation Ordinance shall be known as "*An Ordinance Amending Section 3 of Appropriation Ordinance No. 01-2018 titled "An Ordinance Authorizing Supplemental Budget No. 01 of Tuguegarao City for CY 2018, as to the Use of Funds."*"

SECTION 2. Section 3 (Use of Funds) of *Appropriation Ordinance No. 01-2018 titled "An Ordinance Authorizing Supplemental Budget No. 01 of Tuguegarao City for CY 2018"* is hereby amended to be read as follows:

SECTION 3. The disbursements of funds shall be made subject to the usual accounting, auditing and procurement laws, rules and regulations.


