CITY ORDINANCE NO. 05-2018

**CITY ORDINANCE CREATING THE POSITION OF PHYSICAL THERAPIST II
 WITH SALARY GRADE 15 AT THE STIMULATION AND THERAPEUTIC
 ACTIVITY CENTER AND PROVIDING FUNDS THEREOF**

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the local government units to design and implement their own organizational structure and staffing pattern which will effectively address their respective development plans, programs, objectives and priorities;

WHEREAS, the creation of the above-stated position at the Stimulation and Therapeutic Activity Center will effect personnel movement which will contribute efficiency in the delivery of basic services particularly those which have to do with the programs and projects related to the services of the said office;

WHEREAS, in order to promote bureaucratic efficiency by having an effective personnel force, there is a need for the City Government to create the above-mentioned position at the Stimulation and Therapeutic Activity Center and provide funds thereof.

NOW, THEREFORE, be it **ORDAINED** in the Sangguniang Panlungsod of Tuguegarao City in a session assembled that:

SECTION 1. TITLE. This ordinance shall be known and cited as the "**ORDINANCE CREATING THE POSITION OF PHYSICAL THERAPIST II WITH SALARY GRADE 15 AT THE**

STIMULATION AND THERAPEUTIC ACTIVITY CENTER AND PROVIDING FUNDS THEREOF

SECTION 2. CREATION OF NEW POSITION. For purposes of this Ordinance, there is hereby created the position of Physical Therapist II with Salary Grade 15 at the Stimulation and Therapeutic Activity Center.


SECTION 3. FUNDING. The corresponding fund needed for the salary and other emoluments and benefits for the above-stated position shall be provided in the Second Supplemental Budget of the City of Calendar Year 2018.

SECTION 4. QUALIFICATIONS. All matter pertinent to recruitment and placement for the above created position shall be governed by Civil Service Laws, Rules and Regulations, and such other related issuances.

SECTION 5. EFFECTIVITY. This Ordinance shall take immediately upon its approval.
