
**Madam:**

**CITY ORDINANCE NO. 08-2018**

**AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 19-2016, OTHERWISE KNOWN AS "AN ORDINANCE EXEMPTING INDIGENTS FROM THE PAYMENT OF FILING AND CERTAIN FEES BEING COLLECTED BY THE OFFICE OF THE CITY CIVIL REGISTRAR PURSUANT TO REPUBLIC ACT NO. 9048 AS AMENDED BY REPUBLIC ACT 10172"**

**WHEREAS**, there is a need to amend City Ordinance No. 19-2016 to cater those indigent petitioners above eighteen (18) years of age who are still studying but dependent from parents for support;

**WHEREAS**, it is deemed fit to amend the said Section as there is a growing number of students who are applying for exemption from the payment of filing and certain fees being collected by the City Civil Registrar.

**NOW, THEREFORE**, be it **ORDAINED** by the Sangguniang Panlungsod of Tuguegarao in session assembled, to enact the following:



**SECTION 1. TITLE.** This Ordinance shall be known as “An Ordinance Amending Section 4 of City Ordinance No. 19-2016, Otherwise Known as An Ordinance Exempting Indigents from the Payment of Filing and Certain Fees being Collected by the Office of the City Civil Registrar pursuant to Republic Act No. 9148 as Amended by Republic Act 10172.”

**SECTION 2.** SECTION 4 of City Ordinance No. 19-2016 is hereby amended to read as follows:

**SECTION 4. Minority and Incapacity.** In the case of a minor, insane, demented and deaf mute petitioner, his/her parents, legal guardian or any person duly authorized by law to file a petition in his/her behalf can avail of the exemption to pay the filing fees in the Office of the City Civil Registrar, provided that such parents, legal guardian or any person duly authorized by law shall be qualified as an INDIGENT in accordance to the provisions of this ordinance.

*In the case of a petitioner who is above eighteen (18) years of age but still a tertiary student in any private or public institution, his/her parents, legal guardian or any person duly authorized by law to file a petition in his/her behalf can avail of the exemption as mentioned in the preceding paragraph. The said petitioner must be SINGLE and must present proof of enrolment for the current year to be qualified.*


The same, however, does NOT apply to other petitioners filing on behalf of fully capacitated documents owners with duly notarized Special Powers of Attorney, where indigency shall refer to the document owner.

**SECTION 3. REPEALING CLAUSE.** All ordinances, rules and regulations in conflict with the provisions of this Ordinance are hereby repealed.

**SECTION 4. EFFECTIVITY CLAUSE.** This ordinance shall take effect upon approval.
