
Madam:

CITY ORDINANCE NO. 16-2018

**AN ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR
 TRAFFIC OF PORTION OF AGUINALDO STREET ON APRIL 06, 2018
 FROM 1:00 P.M. TO 9:00 P.M. FOR THE RE-LAUNCHING OF
 MART ONE DEPARTMENT STORE**

WHEREAS, Expressions Stationery Shop, Inc. requested the City Mayor, Hon. Atty. Jefferson P. Soriano, through a letter dated March 7, 2018 for the closure of the road of Bonifacio Corner, Aguinaldo Street, Tuguegarao City, Cagayan for the re-launching of Mart One Department Store;

WHEREAS, the letter has been referred to the Sangguniang Panlungsod for appropriate action and recommendation;

WHEREAS, after finding the same to be in order and in accordance with the pertinent provisions of Section 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod deemed it proper to approve the said request;

WHEREAS, a provision for motor vehicles that will be affected has been identified (Ipil Street);

WHEREAS, the Tuguegarao City Police Station and Public Order and Safety Unit are tasked to implement the said ordinance;

WHEREAS, the above-mentioned provision of the Local Government Code of 1991 authorizes a local government unit to temporary close any local road falling within its jurisdiction.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to enact the following:

SECTION 1. SCOPE AND LIMITATION. This Ordinance shall cover portion of Aguinaldo Street which is hereby declared temporarily closed from vehicular traffic on April 06, 2018 from 1:00 P.M. to 9:00 P.M. for the re-launching of Mart One Department Store.

SECTION 2. INFORMATION. This Ordinance shall be disseminated through lamp post banners in Tuguegarao City.

SECTION 3. IMPLEMENTATION. The Implementing Agency shall be the Office of the City Chief of Police in coordination with the Tuguegarao City Traffic Management Group.

The City Chief of Police shall adopt a system of rerouting traffic in the affected streets and provide adequate loading, unloading and parking areas as well as appropriate access in cases of emergency.


SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.


