CITY ORDINANCE NO. 20-2018

AN ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC OF THE STRETCH OF MAGALLANES STREET CORNER LUNA STREET TO MAGALLANES CORNER GOMEZ STREET DURING THE STRATEGIC HOURS OF 9:00 P.M. TO 4:00 A.M. FOR A PERIOD OF SIX (6) MONTHS TO PRE-EMPT SECURITY THREATS TO PNP STATIONS

WHEREAS, the City Chief of Police, PSUPT Edward M. Guzman, has requested the City Mayor, Hon. Atty. Jefferson P. Soriano, through a letter dated March 22, 2018, for the temporary closure of certain streets of the city particularly at the stretch of Magallanes Street corner Luna Street to Magallanes Street corner Gomez Street during strategic hours of 9:00 P.M. to 4:00 A.M. for a period of six (6) months to pre-empt security threats to PNP Stations;

WHEREAS, the said letter has been referred to the Sangguniang Panlungsod for appropriate action and recommendation;

WHEREAS, PSUPT Edward M. Guzman said that they received an intelligence report that a certain CNN group disguised as government employees or military officials, etc. is planning to harass or attack the police stations, hence, the request for the temporary closure is for precautionary measure to alert the police officers should there be any attacks;

WHEREAS, the temporary closure is for a six-month period, however, in case the security threat no longer exists or the circumstances of which the temporary closure in certain hours on the streets no longer exist, the temporary closure will no longer have any effect;

WHEREAS, the request of PSUPT Edward M. Guzman is in order and in accordance with the pertinent provisions of Section 21(a)(c) and (d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which authorizes the local governments to temporarily close some of its local roads falling within their respective jurisdiction for the purposes enumerated therein.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to enact the following:

SECTION 1. SCOPE AND LIMITATION. This ordinance shall cover the stretch of Magallanes Street corner Luna Street to Magallanes Street corner Gomez Street during the strategic hours of

9:00 P.M. to 4:00 A.M. for a period of six (6) months to pre-empt security threats to PNP Stations. Other alternative routes within the vicinity are available or open.

SECTION 02. INFORMATION. This ordinance shall be disseminated through installation of proper information and barricade.


SECTION 03. IMPLEMENTATION. The Implementing Office shall be the Tuguegarao City Police Station and in coordination with the Tuguegarao City Traffic Management Group.

The implementation shall be subject to the condition that the City Chief of Police shall allow the firetruck of the BFP Station, Rescue 1111 and ambulances to still use the portion of Magallanes Street in case of fire and other emergencies.


SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon approval.
