
Madam:

CITY ORDINANCE NO. 21-2018

AN ORDINANCE AMENDING SECTION 3.1 AND SECTION 3.2 OF ORDINANCE NO. 10-2008, ALSO KNOWN AS ORDINANCE FIXING FARE RATES FOR TRICYCLES FOR HIRE OPERATING WITHIN TUGUEGARAO CITY

WHEREAS, the President of the Tuguegarao City Tricycle Operators and Drivers Association (TCTODA) filed a petition for fare hike within Tuguegarao City due to recent uncontrolled series of increases in the prices of gasoline, motorcycle oil and motorcycle spare parts;

WHEREAS, the Committee on Transportation conducted a public hearing to give the public the chance to express their views on the petition;

WHEREAS, the participants from different sectors did not interpose any objection during the public hearing, however, they suggested that the fare increase should be fair to both the riding public and the tricycle drivers;

WHEREAS, after a thorough deliberation and with the soaring increase of prices of gasoline, motorcycle oil and motorcycle spare parts, the fare increase is necessary;

WHEREAS, for this purpose, there is a need to amend Section 3.1 and Section 3.2 of City Ordinance No. 10-2008, otherwise known as the Ordinance Fixing Fare Rates for Tricycles for Hire Operating Within Tuguegarao City.

NOW, THEREFORE, be it **ORDAINED** by the Sangguniang Panlungsod of Tuguegarao City in session assembled, to enact the following:

SECTION 1. TITLE. This ordinance shall be known as *“An Ordinance Amending Section 3.1 and Section 3.2 of Ordinance No. 10-2008, Also Known as, Ordinance Fixing Fare Rates for Tricycles for Hire Operating Within Tuguegarao City.”*

SECTION 2. Section 3.1 and Section 3.2 of Ordinance No. 10-2008 shall be rephrased to be read as follows:

“SECTION 3. NEW FARE RATE

3.1 NEW FARE IN THE POBLACION

- a. Regular fare within the Poblacion is fixed at P12.00 for the first three (3) kilometres and fifty (50) centavos per succeeding kilometer per passenger.
- b. Students, senior citizens and persons with disabilities shall pay P10.00 for the first three (3) kilometers and 20% discount per succeeding kilometer per passenger.
- c. For purposes of this ordinance, Poblacion consists of Barangays 1-12.




