# **CITY ORDINANCE NO. 31-2018**

CITY ORDINANCE DECLARING THE TEMPORARY CLOSURE FROM VEHICULAR TRAFFIC OF PORTIONS OF GONZAGA, DEL ROSARIO, GOMEZ AND BONIFACIO STREETS FROM JULY 28, 2018 TO SEPTEMBER 17, 2018 FOR THE TRADITIONAL "PRESYO AGAWID"/ BARATILYO 2018

WHEREAS, pursuant to the pertinent provisions of Section 21 (a) (c) and (d) of Republic Act 7160, otherwise known as the Local Government Code, the Local Government Unit of Tuguegarao is authorized to temporary close some of the local roads falling within its jurisdiction for the said purpose;

WHEREAS, the annual celebration of Tuguegarao City's Annual Fiesta has been scheduled on August 11-16, 2018 with a week-long socioeconomic-cultural festivities;

WHEREAS, among the entrepreneurial activities highlighting the traditional fiesta is the conduct of the "Presyo Agawid"/ Baratilyo;

WHEREAS, the usual venues for the "Presyo Agawid"/ Baratilyo are the streets around the Central Market, namely: Gonzaga, Del Rosario and Gomez Streets;

WHEREAS, the "Presyo Agawid"/ Baratilyo 2018 shall be held on August 1, 2018 to September 15, 2018;

WHEREAS, the closure of portions of Gonzaga, Del Rosario and Gomez Streets shall commence on July 28, 2018 to enable the installation and putting up of stalls for the "Presyo Agawid"/ Baratilyo 2018 from July 28 to 31, 2018 and shall end on September 17 for the dismantling of tents from September 16 to 17, 2018;

WHEREAS, a comprehensive and integrated plan on transfer and relocation, traffic management, safety and security, and health and sanitation including the site plan and layout for the conduct of the "Presyo Agawid"/Baratilyo 2018 was submitted;

WHEREAS, there is a necessity of withholding from vehicular traffic the said streets for purposes of the "Presyo Agawid"/ Baratilyo 2018 for the entire period of July 28, 2018 to September 17, 2018 in accordance with the provisions of Section 21 of the Local Government Code of 1991 (RA 7160).

**NOW, THEREFORE**, be it **ORDAINED** by the Seventh City Council in session assembled to enact the following ordinance:

On motion of Hon. Raymund P. Guzman, duly seconded by Hon. Jude T. Bayona, with nine (9) members voting in favor; namely, Hon. Jude T. Bayona, Hon. Kendrick S. Calubaquib, Hon. Arnel T. Arugay, Hon. Winnoco R. Abraham, Hon. Imogen Claire M. Callangan, Hon. Raymund P. Guzman, Hon. Grace B. Arago, Hon. Anthony C. Tuddao and Hon. Karen L. Taguinod, none voting against and one (1) abstention (Hon. Mary Marjorie P. Martin-Chan), this ordinance is hereby approved under suspended rules.

**SECTION 1. TITLE**. This Ordinance shall be known as "City Ordinance Declaring the Temporary Closure from Vehicular Traffic of Portions of Gonzaga, Del Rosario, Gomez and Bonifacio Streets from July 28, 2018 to September 17, 2018 for the Traditional "Presyo Agawid"/Baratilyo 2018."

SECTION 2. SCOPE AND LIMITATION. This Ordinance shall cover certain portions of Gonzaga Street from Corner Bonifacio to corner Del Rosario Street; Del Rosario Street on the western side of the Central Market; and Gomez Street corner Del Rosario Street to corner Bonifacio Street, surrounding the Central Public Market which are declared temporarily closed from vehicular traffic from July 28, 2018 to September 17, 2018 for the conduct of the "Presyo Agawid"/ Baratilyo bargain sale of consumer goods and products in connection with the 294<sup>th</sup> Annual Fiesta of Tuguegarao City.

**SECTION 3. INFORMATION**. This Ordinance shall be disseminated through all mass media outlets in Tuguegarao City.

**SECTION 4. IMPLEMENTATION**. The Implementing Agency shall be the Office of the City Chief of Police in coordination with the City General Services Office and Market Supervisors.

The City Chief of Police shall adopt a system of rerouting traffic in the affected streets, provide adequate loading, unloading and parking areas as well as appropriate access and outlets for firefighting trucks and equipment in case of emergency.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.
