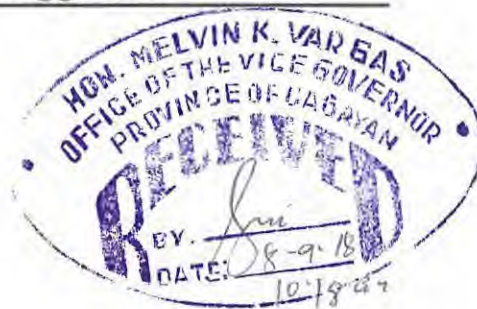


Madam:

CITY ORDINANCE NO. 37-2018

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO TEMPORARILY CLOSE THE ENRILE BOULEVARD, CARIG SUR, TUGUEGARAO CITY IN CELEBRATION OF THE 294th TUGUEGARAO CITY ANNUAL PATRONAL FIESTA "AFI FESTIVAL 2018"

WHEREAS, pursuant to Section 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Government Unit of Tuguegarao is authorized to declare any closure of local roads falling within its jurisdiction;

WHEREAS, Section 458 (6) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlungsod is authorized to exercise such other duties and functions as maybe prescribed by law or ordinance;

WHEREAS, in view of celebration of the 294th Tuguegarao City Annual Patronal Fiesta "AFI Festival 2018", the City Mayor, Hon. Atty. Jefferson P. Soriano, requested for the closure of the Enrile Boulevard, Carig Sur, Tuguegarao City, on some dates to include the practice schedules.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to authorize the City Mayor, Hon. Atty. Jefferson P. Soriano, to temporarily close the Enrile Boulevard, Carig Sur, Tuguegarao City in celebration of the 294th Tuguegarao City Annual Patronal Fiesta "AFI Festival 2018" on the following schedules:


- A. For the *Afi Presentation*: August 08, 2018, from 4:00 P.M. to 9:00 P.M.
- B. For the *Tugsayaw Competition*: August 11, 2018, from 6:00 A.M. to 12:00 NN
- C. For the *Drum and Lyre Competition*: August 12, 2018, from 6:00 A.M. to 12:00 NN

- D. For the Blocking of *Tugsayaw Competition*:
1. August 01, 2018, from 7:00 A.M. to 10:00 A.M. and from 3:00 P.M. to 6:00 P.M.
 2. August 02, 2018, from 7:00 A.M. to 10:00 A.M. and from 3:00 P.M. to 4:30 P.M.
 3. August 04, 2018, from 7:00 A.M. to 10:00 A.M. and from 3:00 P.M. to 6:00 P.M.
 4. August 05, 2018, from 7:00 A.M. to 8:30 A.M.
- E. For the Blocking of *Drum and Lyre Competition*:
1. August 09, 2018, from 6:00 A.M. to 9:00 A.M. and from 4:00 P.M. to 7:00 P.M.
 2. August 10, 2018, from 6:00 A.M. to 9:00 A.M. and from 4:00 P.M. to 7:00 P.M.


On joint motion, **CITY ORDINANCE NO. 37-2018** was **APPROVED** under suspended rules.
