**AN ORDINANCE AMENDING SECTION 3.2 OF ORDINANCE NO. 21-2018, ALSO KNOWN AS "AN ORDINANCE AMENDING SECTION 3.1 AND SECTION 3.2 OF ORDINANCE NO. 10-2008, ALSO KNOWN AS "ORDINANCE FIXING THE FARE RATES FOR TRICYCLES FOR HIRE OPERATING WITHIN TUGUEGARAO CITY", PARTICULARLY DADDA, TAGGA, GOSI SUR AND GOSI NORTE**

**WHEREAS**, the TADAGONAM TODA was not able to raise their issue on fare hike during the public hearing on March 26, 2018 held at the People's Gymnasium relative to the petition of the Tuguegarao City Tricycle Operators and Drivers Association (TCTODA) for fare hike in Tuguegarao City;

**WHEREAS**, after the enactment and implementation of City Ordinance No. 21-2018, the members of the TADAGONAM TODA filed their petition to the Acting City Mayor, Hon. Bienvenido C. De Guzman II, who endorsed the matter to the Seventh City Council for consideration;

**WHEREAS**, the joint Committee on Transportation and Committee on Rules, Laws and Ethics conducted a consultative meeting held on August 07, 2018 at Tagga Barangay Hall which was attended by the barangay officials, residents and members of TADAGONAM TODA;

**WHEREAS**, the TADAGONAM TODA appealed for P1.00 fare increase during the said meeting which was agreed by the participants;

**WHEREAS**, as a result, there shall be an increase of P1.00 on the fare rates of Dadda, Tagga, Gosi Sur and Gosi Norte to Poblacion and vice-versa as shown by the matrix on the next page.

**NOW, THEREFORE**, be it **ORDAINED** by the Sangguniang Panlungsod of Tuguegarao City in session assembled, to enact the following:

**Section 1. Title.** This Ordinance shall be known as “*An Ordinance Amending Section 3.2 of Ordinance No. 21-2018, also known as An Ordinance Amending Section 3.1 and Section 3.2 of Ordinance No. 10-2008, also known as Ordinance Fixing the Fare Rates for Tricycles for Hire Operating Within Tuguegarao City, Particularly Dadda, Tagga, Gosi Sur and Gosi Norte.*”

**Section 2.** Section 3.2 of Ordinance No. 21-2018 is hereby amended to include:

**3.2 THE NEW FARE RATE OF BARANGAYS OUTSIDE THE POBLACION**



**Section 4. Effectivity.** This ordinance shall take effect upon approval.





COMMITTEE REPORT NO. 150-2018

**SUBJECT:**

Indorsement of the Acting City Mayor, Hon. Bienvenido C. De Guzman II, on the Petition of the Officers and Members of the Tagga-Dadda-Gosi-Namabbalan Tricycle Operators and Drivers Association (TADAGONAM TODA) to implement their proposed fare rate.

**ACTIONS TAKEN:**

1. The committees initially met on July 24, 2018 to discuss the merits of the Petition with the presence of the TODA officers.
2. The committees conducted a Consultative Meeting held on August 7, 2018 at 2:00 P.M. held at Tagga Barangay Hall to solicit the opinions of the barangays concerned. The same was attended the barangay officials, residents, officers and members of the concerned TODA.
3. The committees met again on August 31, 2018 to finally discuss the merits of the Petition.

**FINDINGS:**

1. During the public hearing on March 26, 2018 held at the People's Gymnasium relative to the Petition of the Tuguegarao City Tricycle Operators and Drivers Association (TCTODA) for fare hike in Tuguegarao City, TADAGONAM TODA was not able to raise their issue on fare hike. However, after the enactment and implementation of City Ordinance No.21-2018, they filed their Petition to the Seventh City Council to consider their proposed fare hike considering that it was overlooked during the aforesaid public hearing.

2. Pursuant to City Ordinance No. 21-2018, the fare rates from Barangays Tagga, Dadda, Gosi Sur and Gosi Norte to Poblacion and vice-versa are as follows:

3. During the Consultative Meeting, the TADAGO TODA appealed for P1.00 fare increase.
4. There is a need to amend the Fare Matrix in order to reflect the correct fare rates particularly for Barangays Tagga, Dadda, Gosi Sur and Gosi Norte.





The consultative meeting started at 2:40 P.M. with a prayer led by Mr. Rody Tungcul, Barangay Secretary. Hon. Anthony Tuddao, Chairman of the Committee on Transportation, proceeded with the conduct of the consultative meeting purposely to solicit the opinion of the barangays with regard the subject petition.

The Chair explained the Petition. Accordingly, in City Ordinance No. 07-2008, the fare rates for Tagga-Dadda-Gosi-Namabbalan (TADAGONAM) are as follows:

However, City Ordinance No. 10-2008, an ordinance of roll back of P1.00 fare rates in Tuguegarao City was passed sometime in October 2008 which accordingly the TADAGONAM TODA failed to implement.

Then, recently passed City Ordinance No. 21-2018 by the Seventh City Council prescribes the fare rates for TADAGONAM, to wit:

In view of the exiting fare rates, the TADAGONAM TODA are appealing to implement their proposed fare rates hereunder listed for reasons that the riding public are still regularly and habitually paying the old rate as prescribed in City Ordinance No.07-2008.

Then the Chair solicited comments and reactions from the participants.

The following were the issues raised:

- According to the TADAGONAM TODA, they were not informed by their TODA president of the then roll back of fare rates. As a consequence, they continued to implement the fare rates based from the Fare Matrix reflected in City Ordinance No. 07-2008. They also informed that the riding public has customarily used to pay the fare rates that were prior to the rolled back rates up to the present time.
- Considering that the fare increase of P2.00 is now being implemented pursuant to the existing city ordinance, the TODA specifically for Tagga-Dadda-Gosi are appealing if they could be afforded with at least P1.00 fare increase instead of the increase they appealed for in their petition.
- Gosi Norte TODA and Tagga TODA requested that instead of P13.50 fare and P14.50 for both barangays, if it could be possibly rounded off to P14.00 and P15.00 respectively.
- Gosi Sur TODA has raised that the tricycle fare from Barangay Lingaling to Poblacion vice versa is P14.00. Accordingly, Gosi Sur has a longer distance from the Poblacion as compared to Barangay Lingaling. They requested to increase the tricycle fare for Barangay Gosi Sur at P14.00.

The Chair explained that the petition for fare increase should be based from City Ordinance No. 10-2008 and not from City Ordinance No. 07-2008. He likewise advised the concerned TODA not to pursue their threat to boycott conveying the riding public considering that they have benefited for at least ten years of not implementing the roll back then in tricycle fare rates. He assured that in aid of legislation, the committee will do its best in addressing the issue.

There being no other issues raised, the chair thanked the participants and adjourned the meeting at 3:30 P.M.


