AN ORDINANCE CREATING ONE (1) POSITION OF EXECUTIVE ASSISTANT IV AT THE OFFICE OF THE CITY MAYOR AND PROVIDING FUNDS THEREFOR

WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991, empowers local government units (LGUs) to design and implement their own organizational structure and staffing pattern which will effectively address their respective developmental plans, programs, objectives and priorities;

WHEREAS, there is a need to create one (1) position of Executive Assistant IV to assist the City Mayor in the implementation of important Programs, Projects and Activities for the improvement and speedy delivery of basic services to the people.

NOW, THEREFORE, be it **ORDAINED** by the Seventh City Council in session duly assembled to enact:

SECTION 1. TITLE. This Ordinance shall be known as the “*Ordinance Creating One (1) Position of Executive Assistant IV for the City Mayor’s Office of Tuguegarao City and Providing Funds Therefor.*”

SECTION 2. CREATION OF NEW POSITION. There is hereby created the position of one (1) Executive Assistant IV with Salary Grade 22 (Co-terminus).

SECTION 3. FUNDING FOR THE NEW POSITION. Subject to Personal Services Limitation and availability of funds, the corresponding fund for the salary and other emoluments and benefits for the above stated position shall be included as a priority item for appropriation in the Annual Budget and Supplemental Budget of 2018 and in the succeeding Annual/Supplemental Budgets of the City.


SECTION 4. QUALIFICATIONS. All matters pertinent to recruitment and placement for the above created position shall be governed by civil service laws, rules and regulations, and other related issuances.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.
