#### **CITY ORDINANCE NO. 41-2018**

AN ORDINANCE PROVIDING FOR FREE CINEMAS/THEATERS ADMISSION FOR CARD-BEARING SENIOR CITIZENS ON MONDAYS AND PERSONS WITH DISABILITIES (PWDs) ON TUESDAYS WHO ARE RESIDENTS OF TUGUEGARAO CITY IN ALL CINEMAS/THEATERS OPERATING WITHIN THE CITY OF TUGUEGARAO

WHEREAS, Section 11, Article II of the 1987 Constitution provides that "the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, Section (D)(5)(n) of Republic Act No. 8755, otherwise known as the "Tuguegarao City Charter", provides that, the Sangguniang Panlungsod shall approve ordinances and pass resolutions



necessary for an efficient and effective city government, and relative thereto shall provide for the care of disabled persons and the aged;

WHEREAS, the City of Tuguegarao earnestly desires to provide full and meaningful privileges to its senior citizens and person with disabilities in order to make their lives more livable and comfortable in their twilight years.

NOW, THEREFORE, be it ORDAINED by the Sangguniang Panlungsod of Tuguegarao City, THAT:

**SECTION 1. TITLE.** This Ordinance shall be known as "An Ordinance Providing for Free Cinemas/Theaters Admission for Card-Bearing Senior Citizens on Mondays and Persons with Disabilities (PWDs) on Tuesdays who are Residents of Tuguegarao City in all Cinemas/Theaters Operating Within the City of Tuguegarao."

### SECTION 2. DECLARATION OF POLICY.

- A. Consistent with the policies and objectives of the State as set forth under Republic Act No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010", PWD Law and Republic Act No. 9442, the following are hereby declared the policy of Tuguegarao City:
  - 1. To recognize the rights of senior citizens/PWDs to take their proper place in society and make it a concern of the family, community and government;
  - To give full support to the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens/PWDs are integral part of Philippine society;
  - 3. To motivate and encourage the senior citizens/PWDs to contribute to nation building;
  - To encourage their families and the communities they live with to reaffirm the valued Filipino tradition of caring for the senior citizens/PWDs; and,
  - 5. To recognize the important role of the private sector in the improvement of the welfare of senior citizens and PWDs and to actively seek their partnership.
- B. It is declared policy of Republic Act No. 9442 that persons with disabilities are part of the Philippine society, and thus the state shall give full support to the improvement of their total well-being and their integration into the mainstream of society. They have the same rights as other people to take their place in society. They should be able to live freely and as independent as possible. This must be the concern of everyone the family, community and all government and non-government organizations. Rights of persons with disability must never be perceived as welfare services.

SECTION 3. FREE ADMISSION IN CINEMAS/THEATERS. Pursuant to the abovementioned policies, all senior cit zens and persons with disabilities residing in Tuguegarao City and who are in possession of Senior Citizens Identification Cards issued by the Office for Senior Citizens Affairs (OSCA) and Person with Disabilities (PWDs) Identification Cards issued by the Persons with Disability Affairs Office (PDAO) of Tuguegarao City, are hereby granted the privilege of free admission in all movie houses, theaters and cinemas operating within the City during Mondays for senior citizens and Tuesdays for PWDs.

**SECTION 4. HOW TO AVAIL OF THE PRIVILEGE**. To avail of the privilege granted in Section 3 hereof, senior citizens shall be required to present their senior citizens IDs issued by the OSCA and for PWDs IDs issued by the PDAO in Tuguegarao City for proper notation of the authorized personnel of the movie houses, theaters and cinemas: Provided, that a card-bearing senior citizen and PWD shall be allowed to avail of the free admission program only once during the days specified herein and that any person accompanying a senior citizen shall be required to pay the regular admission fee: Provided further, that this privilege cannot be enjoyed on the first day of showing of a particular movie and on legal holidays and special holidays: Provided furthermore, that this privilege shall not apply to junkets, tours, or organized group activities comprising of senior citizens and PWD. Junkets are herein contemplated shall mean a group composed of more than ten (10) senior citizens and PWD: Provided finally, that unauthorized use of the senior citizens IDs and PWD IDs in availing of this privilege shall empower the theater owner/person charged with the operation thereof, to dishonor such privilege and report the same to the OSCA and PDAO of Tuguegarao City.
