

RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Education (DepEd) – Tuguegarao City Division Office, for information.


On joint motion, **CITY RESOLUTION NO. 001-2018** was **UNANIMOUSLY APPROVED** under suspended rules.
