CITY RESOLUTION NO. 002-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO CITY AND CDS BIRTHING CENTER AND AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND IN BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH CDS BIRTHING CENTER

WHEREAS, Section 455, paragraph vi of the Local Government Code of 1991 provides that *“the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance”*;

WHEREAS, the Tuguegarao City Government operates and maintains the Tuguegarao City People’s General Hospital located at Tuguegarao City, Cagayan;

WHEREAS, the Tuguegarao City People’s General Hospital is a secondary/tertiary hospital with highly trained and competent medical practitioners and equipped with medical set-up and equipment as required of a Maternal-Child friendly hospital;

WHEREAS, CDS Birthing Center which handle non-complicated pregnancies with home delivery set-up and which does not handle, treat and manage complicated OB-GYNE procedures as well as pediatric cases has manifested its intent to enter into Memorandum of Agreement with LGU Tuguegarao City;

WHEREAS, the Committee found the terms and conditions provided for in the Memorandum of Agreement beneficial to both parties and the constituents of Tuguegarao City;

WHEREAS, future requests from similarly situated birthing centers shall be submitted for approval to the City Council.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Local Government Unit of Tuguegarao City and CDS Birthing Center and to


