**WHEREAS**, the Supplemental Budget No. 01 of Barangay Caritan Sur for CY 2017 has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

**WHEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Barangay Supplemental Budget No. 01 for Calendar Year 2017 of Barangay Caritan Sur in the amount of P50,000.00 with the condition that all disbursements under Maintenance and Other Operating Expenses (MOOE) shall be subject to the submission of the approved programs of work, Annual/Supplemental Procurement Plan and the usual auditing and accounting procedures.


