RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET NO. 01 OF BARANGAY LIBAG NORTE FOR CY 2017

WHEREAS, the Committee on Appropriations reviewed the Supplemental Budget No. 01 of Barangay Libag Norte for CY 2017;

WHEREAS, the Supplemental Budget No. 01 of Barangay Libag Norte for CY 2017 has complied with the established budgetary requirements as certified by the Local Finance Committee and the same was validated by the Committee on Appropriations.

WHEREFORE, RESOLVE, as it is hereby RESOLVED, to approve the Barangay Supplemental Budget No. 01 for Calendar Year 2017 of Barangay Libag Norte in the amount of P50,000.00 with the condition that all disbursements under Maintenance and Other Operating Expenses (MOOE) shall be subject to the submission of the approved programs of work, Annual/Supplemental Procurement Plan and the usual auditing and accounting procedures.

RESOLVED FURTHER, that the granting of the Productivity Enhancement Incentive (PEI) for the Barangay Supplemental Budgets shall be in accordance with DBM Budget Circular No. 2017-4 dated December 04, 2017.
