CITY RESOLUTION NO. 022-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) ON SISTER-CITIES RELATIONSHIP BETWEEN THE TUGUEGARAO CITY GOVERNMENT REPRESENTED BY CITY MAYOR HON. ATTY. JEFFERSON P. SORIANO AND THE LAOAG CITY GOVERNMENT REPRESENTED BY CITY MAYOR HON. CHEVYLLE V. FARIÑAS, AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT (MOA)

WHEREAS, pursuant to Section 3 (f) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides among others that local government units may group themselves, consolidate and coordinate their efforts, services and resources for purpose commonly beneficial to them;

WHEREAS, the officialdom of Tuguegarao City recognizes the stature of Laoag City as one of the most progressive cities in the country and with the best practices in the area of revenue generation, disaster risk reduction management, solid waste management, tourism and cultural heritage, investment promotion and many others;

WHEREAS, the Tuguegarao City Government manifested its interest to establish a sisterhood collaboration with the City Government of Laoag City through City Resolution No. 022-2018;

WHEREAS, to formalize and make the sisterhood between the two cities legally binding, there is a need for both parties to enter into a Memorandum of Agreement (MOA);

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Seventh City Council to approve the said Memorandum of Agreement (MOA) and to grant him an authority to sign for and in behalf of the Tuguegarao City Government to the said Memorandum of Agreement (MOA);



WHEREAS, after a deliberation in a committee meeting held for the said purpose, the Committee on Rules, Laws and Ethics found the request to be in order and beneficial to the constituents of Tuguegarao City;

WHEREAS, after the presentation and adoption of Committee Report 07-2018, the Seventh City Council during their 68th Regular Session deemed it proper and necessary to approve herein request.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement (MOA) on sister-cities relationship between the Tuguegarao City Government represented by City Mayor Hon. Atty. Jefferson P. Soriano and the Laoag City Government represented by Hon. City Mayor Hon. Chevylle V. Fariñas, and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement (MOA).

RESOLVED FURTHER, to furnish a copy of this resolution to the Laoag City Government, for information and proper action.


