**CITY RESOLUTION NO. 023-2018**

**A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, DEPARTMENT OF LABOR AND EMPLOYMENT – NATIONAL REINTEGRATION CENTER FOR OFWs, REGIONAL OFFICE NO. 02 (DOLE-NRCO RO2) AND OTHER NETWORK PARTNERS AND GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT**

**WHEREAS**, the referral which is “*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of Tuguegarao City the Memorandum of Agreement with the Department of Labor and Employment – National Reintegration Center for OFWs, Regional Office No. 02 (DOLE-NRCO RO2) and Other Network Partners*”, was endorsed to the Seventh City Council;

**WHEREAS**, the Committee, to which the matter was referred, met on January 08, 2018 to discuss the subject referral;

**WHEREAS**, the Program is pursuant to Sections 10 and 11 of Republic Act No. 10022, otherwise known as the Migrant Workers and Overseas Filipinos Act;

**WHEREAS**, the Program which is a collaboration between and among the different concerned line agencies of the government and other stakeholders aims to help and support OFWs particularly the displaced and distressed OFWs by providing access to services in the fields of livelihood, employment, investment, medical/health, psychosocial, economic and spiritual among others;

**WHEREAS**, upon review of the referral, the Committee on Rules, Laws and Ethics recommends for the approval of the Memorandum of Agreement and the granting of authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the



Memorandum of Agreement to be entered into with the Department of Labor and Employment – National Reintegration Center for OFWs, Regional Office No. 02 (DOLE-NRCO RO2) and other network partners.


