### A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE TUGUEGARAO CITY GOVERNMENT, DEPARTMENT OF LABOR AND EMPLOYMENT – NATIONAL REINTEGRATION CENTER FOR OFWS, REGIONAL OFFICE NO. 02 (DOLE-NRCO RO2) AND OTHER NETWORK PARTNERS AND GRANTING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, AN AUTHORITY TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT

WHEREAS, the referral which is "Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf of Tuguegarao City the Memorandum of Agreement with the Department of Labor and Employment – National Reintegration Center for OFWs, Regional Office No. 02 (DOLE-NRCO RO2) and Other Network Partners", was endorsed to the Seventh City Council;

WHEREAS, upon review of the referral, the Committee on Rules, Laws and Ethics recommends for the approval of the Memorandum of Agreement and the granting of authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the
