RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH EXSILENT EAR SOLUTION AND GENERAL MERCHANDISE FOR THE CONDUCT OF NEWBORN HEARING SCREENING

WHEREAS, to ensure that all newborns have access to newborn hearing screening as provided by the Universal Hearing Screening and Intervention Act of 2009 (R.A. No. 97091), the Department of Health (DOH) implements the Universal Newborn Hearing Screening Program through training, certification and quality assurance of newborn hearing screening centers and management of a registry;

WHEREAS, the Tuguegarao City Government desires to include this in the health services being offered by the Tuguegarao City People’s General Hospital (TCPGH);

WHEREAS, it shall not be mandatory on the part of the parents to Contract Exsilent Ear Solution and General Merchandise for the newborn screening;

WHEREAS, the Tuguegarao City Government through the TCPGH shall be given a portion of the fees as indicated in the schedule of fees in the approved Memorandum of Agreement;

WHEREAS, the Exsilent Ear Solution and General Merchandise agrees to provide newborn hearing screening, Pure Tone Audiometry and supply of Hearing Unit to the patients of the Tuguegarao City People’s Hospital;

WHEREAS, the City Mayor requested for an authority to sign the Memorandum of Agreement from the City Council;



WHEREAS, the said request has been referred to the Committee on Health and Sanitation;


WHEREAS, after finding the same to be meritorious and in order, the Committee on Health and Sanitation favorably recommends the passage of a Resolution approving the Memorandum of Agreement and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with Exsilent Ear Solution and General Merchandise for the conduct of Newborn Hearing Screening.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government with Exsilent Ear Solution and General Merchandise for the conduct of Newborn Hearing Screening.


