RESOLUTION RECOMMENDING THE APPROVAL OF THE MEMORANDUM OF AGREEMENT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE LOCAL GOVERNMENT OF TUGUEGARAO CITY THE MEMORANDUM OF AGREEMENT WITH THE EYE CAN PHILIPPINES, INC. (EYE CAN CATARACT SURGERY CENTER)

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested for an authority to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with Eye Can Philippines, Inc. (Eye Can Cataract Surgery Center);

WHEREAS, the Eye Can Philippines, Inc. needs the medical facilities of the Tuguegarao City People's General Hospital (TCPGH) in cases of cardiopulmonary and/or systematic related emergencies as a requirement of the Department of Health (DOH) and PhilHealth in the renewal of their license to operate;

WHEREAS, the said request has been referred to the Committee on Health and Sanitation;

WHEREAS, the Committee finds the same to be in order and beneficial for the Tuguegarao City Government and favorably recommends the approval of the Memorandum of Agreement and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Local Government of Tuguegarao City the Memorandum of Agreement with Eye Can Philippines, Inc. (Eye Can Cataract Surgery Center);

WHEREAS, upon the transfer of patients to the TCGPH, the administration of doctors and nurses shall be under the supervision of the TCGPH and that only when medicines are not available in TCGPH that medicines from outside shall be accommodated.




