**CITY RESOLUTION NO. 027-2018**

**RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, AND CITY TREASURER, MR. BUENAVENTURA F. LAGUNDI, TO OPEN A BANK ACCOUNT FOR THE AUTO-CREDIT PAYMENT SCHEME FOR THE PHILHEALTH BENEFIT PAYMENT OF TUGUEGARAO CITY PEOPLE’S GENERAL HOSPITAL**

**WHEREAS**, Dr. Ray A. Dulig, Chief of Hospital of Tuguegarao City People’s General Hospital (TCPGH), has informed the City Mayor of the directive from the PhilHealth Regional Office 02, of the need to open a bank account for the Auto-Credit Payment Scheme (ACPS) for PhilHealth benefit payment of the Tuguegarao City People’s General Hospital;

**WHEREAS**, there is an urgent need to comply with the said directive from the PhilHealth since the benefit payment through ACPS shall be effective beginning January of this year;

**WHEREAS**, in view of the above-mentioned directive from the PhilHealth, the City Mayor has requested for an authority from this Body to open a bank account for the Auto-Credit Payment Scheme (ACPS) for the PhilHealth benefit payment of TCPGH;

**WHEREAS**, the said request of the City Mayor has been referred to the Committee on Health and Sanitation as the lead committee and the Committee on Appropriations;

**WHEREAS**, after a careful deliberation on the matter, the Committee finds the same to be meritorious and in order and favorably recommends the passage of a Resolution granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, and City Treasurer, Mr. Buenventura F. Lagundi, to open a bank account for the ACPS for PhilHealth benefit payment of the TCPGH.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano and City Treasurer, Mr. Buenventura F. Lagundi, to open a bank




