**CITY RESOLUTION NO. 029-2018**

**RESOLUTION APPROVING THE MEMORANDA OF AGREEMENT AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE MEMORANDA OF AGREEMENT WITH THE DEPARTMENT OF HEALTH, REGIONAL OFFICE NO. 02 AND THE RECIPIENTS OF THE MIDWIFERY SCHOLARSHIP PROGRAM OF THE PHILIPPINES (MSPP)**

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code, states that the functions and responsibilities for the delivery of basic health services and other related facilities have been transferred from the Department of Health, Regional Office No. 02 (DOH RO2) to the Local Government Unit (LGU);

**WHEREAS**, the DOH, pursuant to its mandate to provide adequate and appropriate human resource for health in marginalized areas, entails the delivery of quality healthcare services in a devolved LGU to include the management of clinical, administrative and public health aspects;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested for an authority to sign the Memoranda of Agreement from the City Council;

**WHEREAS**, the said request has been referred to the Committee on Health and Sanitation;

**WHEREAS**, Ms. Elena Rose P. Tappa and Ms. Kathy May N. Tuliao are the recipients of the two-year Midwifery Scholarship Program of the Philippines (MSPP) by the DOH;

**WHEREAS**, Ms. Elena Rosa P. Tappa and Ms. Kathy May N. Tuliao agree to serve as per "return service" and have been assigned by the DOH RO2 to the Local Government of Tuguegarao City, an identified priority area of the DOH RO2 as a Rural Health Midwife (RHM) under the Rural Health

Midwife Placement Program (RHMPP) for a period of four (4) years upon completion of the scholarship grant;


**WHEREAS**, after finding the same to be meritorious and in order, the Committee on Health and Sanitation favorably recommends the passage of a Resolution Approving the Memoranda of Agreement and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the Memoranda of Agreement with Department of Health, Regional Office No. 02 and the recipients of the Midwifery Scholarship Program of the Philippines.


