CITY RESOLUTION NO. 030-2018

RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO GRANT A LOT OWNED BY THE TUGUEGARAO CITY GOVERNMENT WITHIN THE COMPOUND OF THE CITY HALL BUILDING, CARIG SUR, TUGUEGARAO CITY TO PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE CONSTRUCTION OF ITS BUILDING

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal government agency for raising and providing funds for health programs, medical assistance and services, and charities of national character;

WHEREAS, majority of the clients of PCSO are residents of Tuguegarao City, hence, its office should preferably be situated in Tuguegarao City which is an area accessible and convenient to clients especially to Tuguegaraoenos;

WHEREAS, with the herein premise, it is deemed proper, necessary and beneficial not only to the residents of Tuguegarao City but also to clients of nearby towns and the whole region that the location of PCSO will be in Tuguegarao City;

WHEREAS, the lot to be given to PCSO shall be through a deed of usufruct, the terms and conditions of which shall be specified therewith, to be approved by the Seventh City Council.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to grant a lot owned by the Tuguegarao City Government within the compound of the City Hall Building, Carig Sur, Tuguegarao City to Philippine Charity Sweepstakes Office (PCSO) for the construction of its building.


RESOLVED FURTHER, that a copy of the deed of usufruct be furnished to PCSO for consideration and appropriate action.
