CITY RESOLUTION NO. 032-2018

RESOLUTION APPROVING THE REQUEST OF MS. JENIFER KAYCEE ALMAZORA, REPRESENTATIVE, RADIANT BAY GAMES AND ENTERTAINMENT CORPORATION FOR A RESOLUTION OF NO OBJECTION (RONO) AS A PRE-REQUISITE IN THE ESTABLISHMENT AND OPERATION OF AN ELECTRONIC GAMES/E-BINGO AT THE TUGUEGARAO CITY COMMERCIAL CENTER, TUGUEGARAO CITY

WHEREAS, Ms. Jenifer Kaycee Almazora, Representative, Radiant Bay Games and Entertainment Corporation, requested for a Resolution of No Objection (RONO) from the Sanggunian as part of the requirements of the Philippine Amusement and Gaming Corporation (PAGCOR) in the establishment and operation of an Electronic Games/E-Bingo at the Tuguegarao City Commercial Center, Tuguegarao City;

WHEREAS, Ms. Jenifer Kaycee Almazora has complied with following documentary requirements:

- a. Philippine Amusement and Gaming Corporation (PAGCOR) Application Form for the establishment of Gaming Site
- b. Lease Proposal between XRC Resources, Inc. and Radiant Bay Games and Entertainment Corporation
- c. Special Power of Attorney authorizing Ms. Jenifer Kaycee Almazora to represent Radiant Bay Games and Entertainment Corporation
- d. Site Floor Plan
- e. Certificate of Incorporation
- f. Unified Registration Record (URR)
- g. Articles of Incorporation

WHEREAS, the management of Radiant Bay Games and Entertainment Corporation shall prioritize employment of qualified residents from Tuguegarao City and that the gaming place be assured with utmost security;

WHEREAS, the failure of Radiant Bay Games and Entertainment Corporation to follow the operational procedures of PAGCOR and/or its engagement in unscrupulous transactions shall be ground for the revocation and cancellation of its RONO;

WHEREAS, the operation of Radiant Bay Games and Entertainment Corporation shall be governed and subjected to the provisions of local laws and ordinances of Tuguegarao City;


WHEREAS, Committee Report No. 005-2018 of the Committee on Games, Entertainment and Amusement and Committee on Rules, Laws and Ethics recommending the passage of a Resolution of No Objection (RONO) as a pre-requisite in the establishment and operation of an Electronic Games/E-Bingo at the Tuguegarao City Commercial Center, Tuguegarao City was duly adopted during the 70th Regular Session of the Sangguniang Panlungsod.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the request of Ms. Jenifer Kaycee Almazora, Representative, Radiant Bay Games and Entertainment Corporation for a Resolution of No Objection (RONO) as a pre-requisite in the establishment and operation of an Electronic Games/E-Bingo at the Tuguegarao City Commercial Center, Tuguegarao City, subject, however, to compliance with the PAGCOR guidelines on the operation of Electronic Games/E-Bingo.


On motion of Hon. Anthony C. Tuddao, with nine (9) members voting in favor and two (2) against (Hon. Que and Hon. Chan), **CITY RESOLUTION NO. 032-2018** was **APPROVED** under suspended rules.
