**CITY RESOLUTION NO. 037-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING WITH THE ENVIRONMENTAL MANAGEMENT BUREAU, REGIONAL OFFICE 02 (EMB-R02) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF UNDERSTANDING**

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested for an authority to sign the Memorandum of Understanding with the Environmental Management Bureau, Regional Office 02 (EMB-R02) for bamboo propagules;

**WHEREAS**, there is a need to rehabilitate the Pinacanauan de Tuguegarao (area within its jurisdiction) in order to preserve as a source of water for domestic use;

**WHEREAS**, the Environmental Management Bureau, Regional Office 02 (EMB-R02) is willing to provide one thousand (1,000) pieces of bamboo propagules for the planting activity to attain the objective of rehabilitating the river;

**WHEREAS**, the Seventh City Council, upon review of the Memorandum of Understanding during its Special Session on February 01, 2018, found the same to be in order, with merit and beneficial to Tuguegarao City Government.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the Memorandum of Understanding with the Environmental Management Bureau, Regional Office 02 (EMB-R02) and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Understanding.


